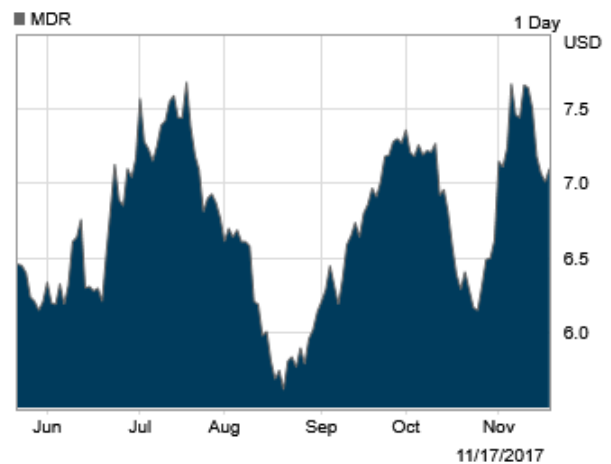
Corporate Profile
